All buses have state-of-the-art securement systems to secure customers' mobility devices. It's required that mobility devices be secured. The operator will assist you with the mobility device securements and the optional lap/shoulder belts as requested. NJ TRANSIT also offers kneeling buses for people who have difficulty with the first step up into the bus. When a bus "kneels" the first step lowers several inches toward the ground. All buses are equipped with this feature. If you would like to use the kneeling feature, simply ask the bus operator to make the bus kneel, then board as usual. Seating located nearest to the front door is designed and designated to provide easy access for people with disabilities.
